

LAND HISTORY FORM

This form must be filled out if the bona fide/legitimate property is deceased detailing the history of the land. The questions below are arranged to gather maximum information from the property owner/s about the land tenure.

This document must be signed by current landowner/s, applicant and stamped, signed, and sealed by a Justice of the Peace (J.P.) This must also be accompanied by the requested supported documents, contact information and government identification (Driver's License, National ID, Passport) for current landowner/s.

Please list full names of former or previous landowner/s	
Please list full names of the current landowner/s	
Address and parish of property (as stated on property tax receipt)	
Please list how many children (with their names) the previous landowner had. State if they are alive, deceased and do they have ties (part owner) to the land that applicant needs assistance to build on?	
Clearly state how the land was passed down, was it as a gift or through a Will. If it is a Gift a copy should be submitted. E.g., Deeds of Conveyance If it is a Will a copy should be submitted	
Clearly state if the land was purchased. If yes, a copy of proof purchase should be submitted. E.g., Agreements for Sale, Lease and sale Agreement, Receipts of payment, land indenture, Surveyor's report, Wills, Court Orders etc.	
If there is no proof of purchase, clearly state: - 1. How many acres was purchased? 2. The sum of money paid for the land, 3. Are payments for the land completed? 4. Was the land surveyed. If yes, copy of surveyor's report should be submitted to food for the poor.	

<p><u>Declarations of Relations</u></p> <p><u>Clearly state the following: -</u> Relationships must be stated between current landowner/s and applicant/s if it is not a lease agreement.</p> <p>Relationships must be stated between deceased landowner/s, previous landowner/s and/or current landowner/s.</p> <p>e.g., mother, father, sister, brother, cousins, aunts, grandparents etc.</p>	
<p>Please state telephone number for current landowner/s</p> <p>Please submit a copy of the landowner's identification card For e.g. (Driver's License or Passport or National ID government ID)</p>
